Fraser Health Authority (FHA) Instructions for Obtaining Recommended Vaccinations and/or Tests

The recommended vaccinations can be obtained by making an appointment at a pharmacy included on our pharmacy contact list. These vaccinations should be at no cost to you as long as you identify yourself as a Health Care Worker.

Step 1: Vaccination appointment booking

Review the list of pharmacies (refer to FHA Pharmacy Listing) providing Health Care Worker (HCW) vaccinations and contact them directly to confirm vaccine availability and book appointments.

NOTE: Live vaccines (i.e., MMR and/or Chickenpox vaccines) should be given on the same day or separated by at least 28 days (4 weeks) to be considered a valid dose. Please ensure enough time has elapsed between vaccination(s) before booking an appointment, as particular vaccination(s) require specific timing/spacing between doses. If unsure, discuss with the pharmacist/vaccinator when your next vaccination(s) would be due.

Bring the following 3 items to your appointment:

- Fraser Health Photo ID and ensure you identify yourself as a HCW,
- BC Health Card, and
- Be prepared to show the recommended vaccine(s) information to the pharmacist (either print the email, including attachments, show it from your mobile device, or bring the mailed copy of vaccination/test recommendations).

*Please note that there should be <u>no fees for HCW recommended vaccinations</u>, which have been <u>confirmed with the listed pharmacies</u>. Fraser Health will not reimburse staff if they choose to obtain a vaccination at another location that charges any immunization or appointment fees.

Step 2: Report your vaccinations/tests

- If you have vaccination/test updates or records, please submit them using the Vaccination Status Self-Reporting tool at: https://healthandsafety.healthcarebc.ca by selecting the "Existing Employee" option.
- If you receive vaccinations at a PHSA, VCH, or Island Health staff immunization clinic, the records will be updated in your employee record accordingly.

Note: If your COVID-19 vaccine was given outside of BC, please use the link: https://immunizationrecord.gov.bc.ca/ to register your COVID-19 vaccine into the Provincial Immunization Registry (please use Chrome).

Step 3: Self-look-up report

- To access your employee vaccination & immunity status, refer to the self-look-up report by selecting the link: FHA or by copying the link: https://ohsbi.phsa.ca/sites/fha/OHS/WMO05003.rdl (please use Chrome or Edge)
- Your self-look-up report is only accessible from the health organization networks.

Step 4: IF lab tests are recommended

<u>If</u> lab tests have been recommended for you, please follow up with a Health Care Provider (HCP) to discuss post-vaccine testing.

- **NOTE:** If you have had a previous Reactive (Immune) Hepatitis B titre (blood test), please contact the Provincial Workplace Health Contact Centre (PWHCC) to discuss this with a nurse <u>before</u> following the above instructions.
- Please follow up with your HCP for your titre results to determine if further vaccinations may be recommended.
